Important Trustee Information

- We are *normally* allowed **24** voting members, but with the “special circumstance” provision and the election of Trustees to a third term up to two years, we currently have **25**. Of the 25 Trustees, 12 are retired military (48%) and 13 are civilian businessmen/women (52%).
- **Seven** Trustees complete their second or third terms at the September 2022 meeting. **Four** of those complete their special and final third terms: Eder, Muedeking, Packett, and Schultz. **Three** complete their normal second terms: Fontaine, Pohanka, and Visot. LTG Keen is an **additional** Trustee scheduled to depart in September 2022 due to his retirement as Chair. The other three officers (Vice Chair, Secretary, and Treasurer) also complete their officer terms in September 2022. An election slate for the March meeting is provided separately.
- **Three** Trustees complete their first terms in September 2022 (Becker, Peterson, and Wolf) and are recommended for re-election to second terms.
- The transition between Outgoing and Incoming Trustees is official at the conclusion of each September meeting. In the event a vote is needed at that meeting, the Outgoing Trustees vote.
